During the procurement of 100 passbook printers through GeM vide tender # GEM/2023/B/3238538 dated 13th March 2023 it was observed that, Bank received single bid from M/s LIPI Data Systems Ltd. M/s TVS Electronics Ltd. did not participate. Other bidders were unable to participate due to MII clause restriction. So in order to increase the participation of more number of OEMs and to avoid monopoly of single OEM or duopoly of only two OEMs in this tender Bank has opted out from applicability of MII clause criteria. Hence, no change.
