The service rendered by us is always to your highest satisfaction. In the last Tender bidding we secured Second position and accordingly allotted us cluster IV (i.e. Branches in Mayurbhanj and Keonjhar districts) and we performed our job without complaint either from your side or from GOVT side complying with GOVT rules in this respect.  At present we have no client other than yours and we have 49 guards on our roll. We assure you that we are capable of arranging trained/experienced guards at any point of time according to demand. In the current tender which is due for opening on 21.12.2021, the condition stipulated therein is that the parties who have Three Hundred guards on roll and Turnover of Rs.3,00,00,000/- per annum can only participate in this tender. Further, we would like to mention here that the four Private Security Agencies Presently engaged in four clusters are doing the monthly business turnover ranging about from two lakh to fifteen lakh and yearly turnover was asked for Rs.50,00,000/- in the last tender which was convenient for bidding.
