- 3. All routers should be delivered within 15 days from date of release of the Purchase Order.
- 4. Time of delivery should be mentioned beyond which there will be a penalty of 0.5 % up to 5% per week of delay (Undelivered Portion) in delivery and in installation.
- 5. There should be 3 years of on-site warrantee from date of delivery of router(s) at Head Office of Odisha Gramya Bank with back-to-back support from OEM.
- 6. The quote should have validity for 60 days.
- 7. 90% payment on delivery and rest 10% will remain with bank for warranty period of the Hardware or till submission of Bank Guarantee for equal to 10% of Order Value (excluding taxes) for period of 3 years with claim period of 6 months.
- Bank reserves right to cancel the bid at any time before issuance of purchase order without assigning any reason.
- 9. Delivery should be done within 4 weeks of release of purchase order.
- 10. Bank has rights to amend/modify any typing/material error before the delivery.
